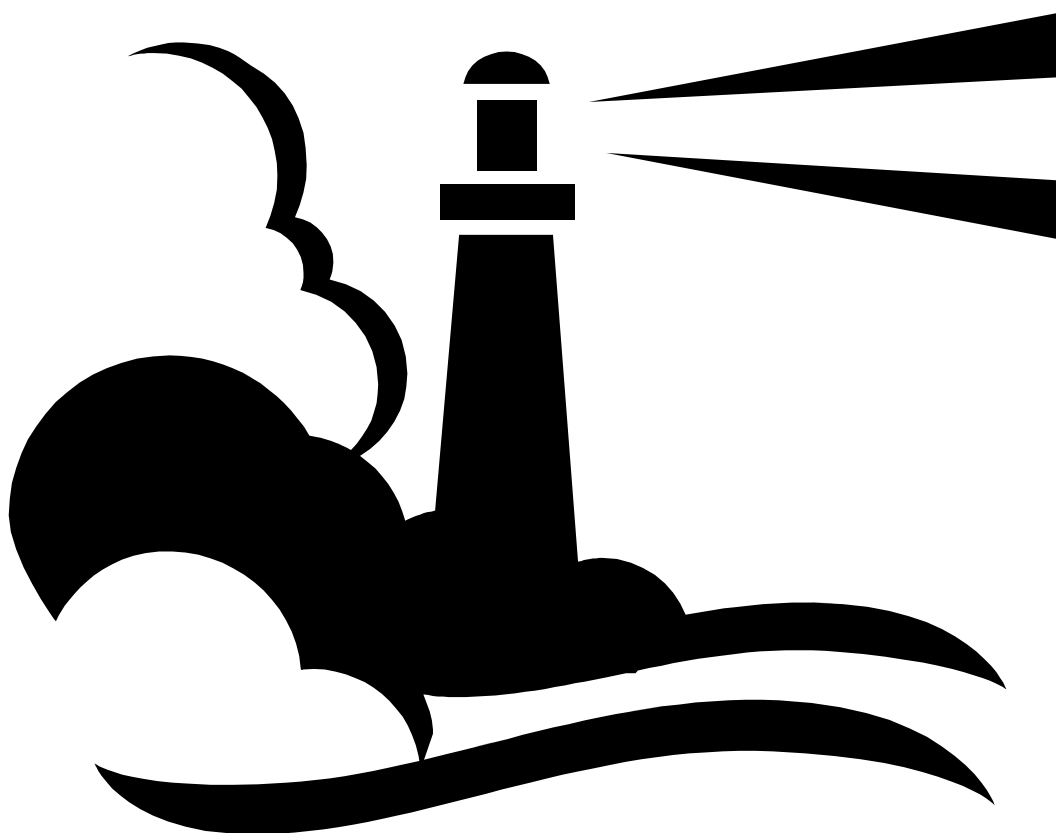

## President's Report- 2020-2021

I would like to thank all the officers and directors of the Board of Directors for carrying out the tasks for this year. They worked hard and contributed many ideas and suggestions for trying to promote bowling. We experienced an exceedingly difficult year due to the affects of the Covid-19 pandemic. We had to cancel last years' annual meeting because the Governor had lock down measures in place for our health safety. When possible, the board continued to meet through Zoom Meetings. We kept the same Board members and cancelled the local association tournaments. The directors' dedication and ability to work well together as a team has aided tremendously in the completion of another successful 2020/2021 bowling season. The meetings were run well and timely.

I would also like to thank Biggi Damm for doing an outstanding job as the Association Manager. She did a great job of processing and distributing the awards and processing member applications. She communicated well with the secretaries to insure that everything was processed. Biggi did a great job of building a rapport with the secretaries.

We also suffered a blow to our membership due to the permanent closing of the Portsmouth Naval Shipyard bowling center and Dover Bowl's conversion to string bowling. This style of bowling is currently not sanctioned by USBC. As a result of these developments, our membership was reduced by almost half. We're hoping that the string bowling centers will be sanctioned in the near future.

Lastly, I would like to thank the bowlers and centers for supporting our organization.

We are always looking for individuals who are willing to join the board and dedicate their time to keeping the association moving in the right direction. We are trying to find new ways to attract participation. Going forward, there will be a couple of key initiatives which affect the Board of Directors: The Registered Volunteer requirement and the importance of attending the few meetings that we have each year (4 to 6).

The association still has a few outstanding matters to address such as getting the league secretaries and presidents to become more involved with the Association and fine tuning the communication with leagues. We also need to strengthen the youth bowling activities. The responsibility and duties of the board are currently managed by a few individuals, but we need involvement from the whole bowling community; from the youth or adult bowler who is just starting out, to the experienced bowler with a high average if we are going to keep bowling alive and fun! Helpers don't have to be actual Board members!

***It is imperative to remember that we need the support and participation from the bowling community to make 2021/2022 bowling season another successful year! New ideas and suggestions are always welcome!***

**Note: Youth Membership Fees are \$4.00 for National.**

STANDARD memberships purchased in a summer league are valid only for that summer. All season memberships expire on 7/31 of that season. **Life members do not pay any membership, and they are listed on the association official list found in the yearbook.**

Seacoast Association will be processing all youth members at Dover Bowl and Strikers East.

Dues should be collected and forwarded to Seacoast NH USBC for all bowlers in your league. **We do not accept Credit Card payments.** Checks are payable to "Seacoast NH USBC." Checks from the individual bowler will be accepted, however checks from the league secretary/treasurer are not accepted, checks must be drawn from the league account.

Please make sure all membership application cards are complete and legible. The bowler's ID# is very important and can be found on their previous sanction card, yearbook or bowl.com. Maintaining one ID number ensures an accurate history of the bowler's achievements, memberships, tournaments, etc. with USBC, state and local associations. **The bowler's ID number does not change from year to year.** Please inform your bowlers that by checking the appropriate box on the membership card they do not have to receive non USBC mail.

## **2. 2020 Legislative Update**

- A. Bowling Ball Drilling Rule Changes- The rule states that all holes in a bowling ball must be used on every delivery. Additionally, bowlers who do not use their thumb when delivering the ball will need to mark, by scribe or engraver tool, a plus sign (+) near the intended center of palm.
- B. Youth memberships available to individuals who have not reached their 18<sup>th</sup> birthday prior to August 1<sup>st</sup> of the current bowling season
- C. Rule 102e, Item 9, Duties of the Secretary Requires final averages to be submitted to the Association Manager within 15 days of the completion of the league.

## **3. Awards**

USBC only provides adult or youth awards for high achievement 300-game and 800-series recognition. The Seacoast NH Local Association will continue to issue some game and series awards. Please see the enclosed award application or select it from the Seacoast NH website ([www.seacoastnhusbc.com](http://www.seacoastnhusbc.com)). You can also submit the awards form from the BLS software. Bowler must meet the average criteria for the achievement to earn the award. Applications and submittals must be sent to the Association Manager within **30 days** of the achievement date so the league bowler can be recognized in a timely manner. This will also ensure award availability. The Association Manager must also be notified within **48 hours** of any high achievement score and the application should be submitted within 30 days..

## **4. Parental Consent**

A "Parental Consent" form must be completed by the parent or legal guardian of any unmarried grade or high school student under the age of 18 who wishes to join an adult league. Also, USBC Athlete Safety Program requires adult members 18 years of age or older who bowl in a league with USBC Youth members 17 years of age or younger to complete the U. S. Center for SafeSport training on a yearly basis.

This checklist is a quick review of the league's operational duties. The details of each officer's duties can be found in the Playing Rules book and in the following pages of this manual.

## **The basics of getting your league up and rolling...**

- ☐ Have a meeting to adopt rules before the first session of bowling.
- ☐ Establish the league account with two signatures for withdrawals and statements sent to the president.
- ☐ Post a league schedule in center or distribute to each team captain.
- ☐ Have all bowlers complete membership applications and pay fees in accordance with USBC Rule 101.
- ☐ Send completed USBC league application and fees to your local association(s) within 30 days from the start of the schedule.
- ☐ Adopt a prize/awards list within five (5) weeks of the start of the schedule.
- ☐ If your league includes bowlers under age 20, discuss Youth Membership Eligibility Rule 400 with league members.
- ☐ If your league includes unmarried grade or high school students under the age of 18, a parental consent form must be completed and submitted.

## **The basics of keeping your league rolling...**

- ☐ Post or distribute current standing sheet. You can also upload the standing sheet on BOWL.com.
- ☐ Distribute recap sheets and pay envelopes.
- ☐ Collect all fees and pay bowling center fees.
- ☐ Deposit money into the league account within seven days.
- ☐ Collect recap sheets and calculate the league records.
- ☐ Check if any awards were earned and process within 20 days of the score bowled. A complete list of USBC awards can be found on BOWL.com.
- ☐ Have new bowlers complete membership applications and pay fees in accordance with USBC Rule 101.
- ☐ President or Youth league supervisor must verify league account balance monthly.





## Consent Form (for Youth bowling in Adult competition)

This form must be given to EACH competition official prior to bowling, substituting or pacing in any USBC Adult competition. (The form is not necessary for youth or adult/youth competitions.)

### USBC Rule 13:

Individuals under the age of 18 must have written consent of a parent or legal guardian before participating in any USBC Adult league or tournament.

When individuals under the age of 18 participate in any such competitions, the consent form must be on file with each league secretary or tournament manager prior to participation, and:

- A. Must be signed by youth and parent/legal guardian
- B. Must be given to league secretary or tournament manager
- C. Is good only for the duration of that specific event

Failure to file the Consent Form will cause the player to be ineligible and subject games bowled to forfeiture or disqualification. (See USBC Rules 119 for leagues and 329 for tournaments.)

### By signing this form, I certify:

1. I have read and understand Rule 400 as it applies to participating in this competition and the effect it may have on USBC Youth membership.
2. I understand to ensure compliance with grade, high school and collegiate competition I should check with the compliance officer and/or athletic/activities association.
3. I understand accepting prizes may be in violation of Rule 400, which is subject to disciplinary action including the potential loss of USBC Youth membership.
4. I understand by bowling in, or accepting any prizes, eligibility to compete in grade/high school and collegiate athletics may be jeopardized.
5. I agree, as a parent or guardian, that I have access to and have read the U.S. Center for SafeSport policies, adopted by USBC, which are available at [https://www.bowl.com/Registered\\_Volunteer\\_Program/RVP\\_Home/RVP\\_Policies/](https://www.bowl.com/Registered_Volunteer_Program/RVP_Home/RVP_Policies/).
6. I agree, as a parent or guardian, that I (or an authorized adult I have designated) will be in the presence of my child at all time during any adult league or tournament.

# **New USBC Rules for 2021-2022**

**Rule 309a** – Tournament Management must make available a copy of the final prize list and financial statement to any participant who requests it within one year of the end of the tournament. This information can be provided in either hard copy or via electronic means.

## **COVID rules to remain in effect for 2021-2022**

**Because of the COVID-19 pandemic, USBC has enacted several rules that impact bowlers. Rule 14 - Emergency Authorization** allows USBC to temporarily modify the General Playing, Awards, League and Tournament Rules under specific circumstances. Information regarding any active authorizations will be posted on BOWL.com.

## **Rules affected under Rule 14 include:**

**Rule 18** - USBC will temporarily allow the use of isopropyl alcohol, aka rubbing alcohol, on the outer surface of the ball at any time during USBC-certified competition.

**Rules 320a and 320b** - USBC will temporarily allow individual teams to compete on a single lane without the requirement to rotate lanes after each frame.

**USBC High Score Awards and Average Recognition** - USBC will temporarily extend recognition of scores bowled on a single lane for USBC High Score Awards and for inclusion in the individual's official average records.

## **Balance hole rule reaches FIRST ANNIVERSARY**

The rule eliminating balance holes in bowling balls took effect Aug. 1, 2020, for the start of the 2020-2021 bowling season. The rule states all holes in a bowling ball must be used on every delivery; any hole not used is considered a balance hole, making the ball illegal.

Bowlers who do not use their thumb cannot have a thumb hole, as it now is considered a balance hole. They also need to mark their ball **by scribe, engraver or tool near the intended center of the palm with a plus (+) mark** to show where they place their palm on delivery.

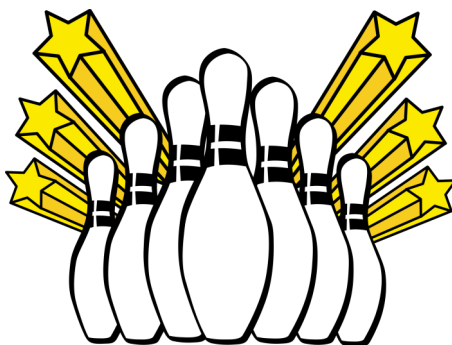

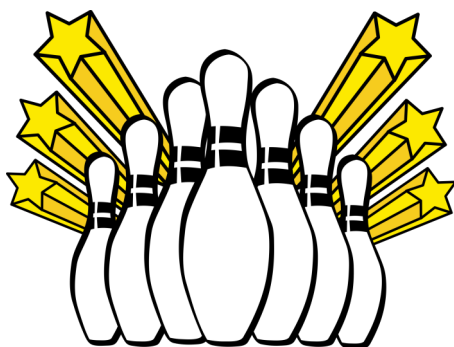
