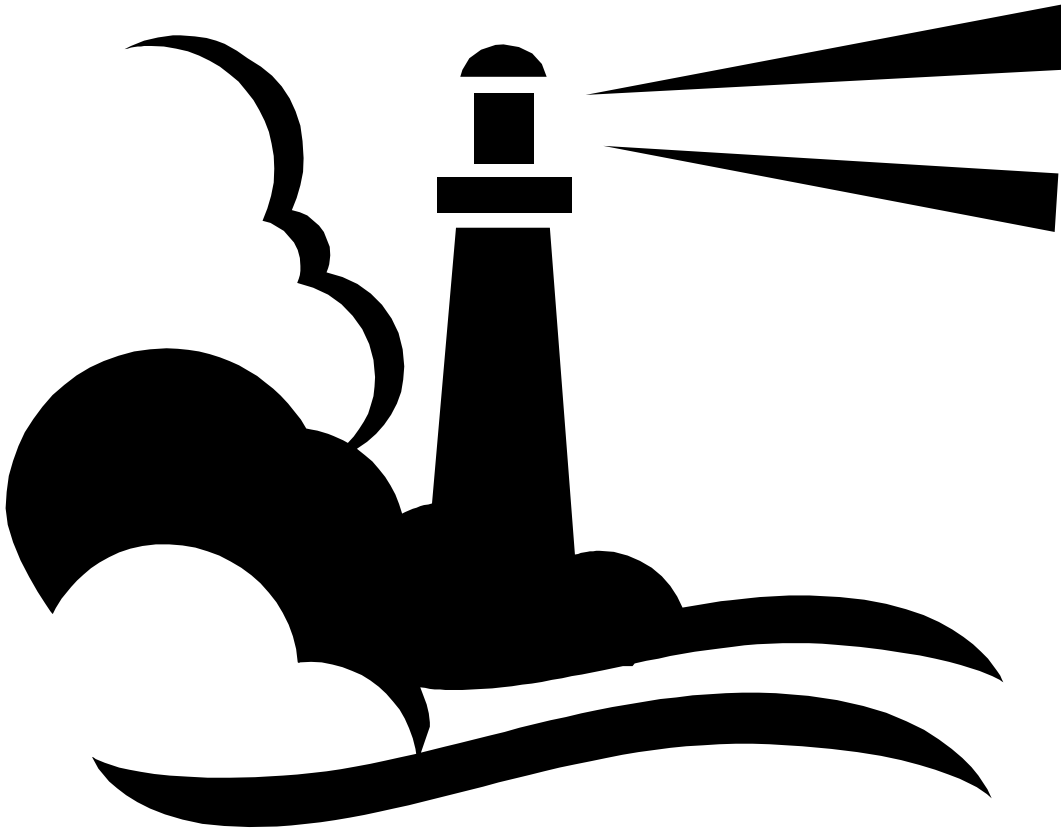

Welcome to the 2023-24 season. Seacoast NH USBC (#81034) is a merged association servicing all adult and youth members of leagues bowling at Strikers East (certification #5510).

1. League Application and Membership Dues

Note: Youth Membership Fees are \$4.00 for National.

STANDARD memberships purchased in a summer league are valid only for that summer. All season memberships expire on 7/31 of that season. **Life members do not pay any membership, and they are listed on the association official list found in the yearbook.**

Seacoast Association will be processing all youth members at Strikers East.

Dues should be collected and forwarded to Seacoast NH USBC for all bowlers in your league. **We do not accept Credit Card payments.** Checks are payable to "Seacoast NH USBC." Checks from the individual bowler will be accepted, however checks from the league secretary/treasurer are not accepted, checks must be drawn from the league account.

Please make sure all membership application cards are complete and legible. The bowler's ID# is very important and can be found on their previous sanction card, yearbook or bowl.com. Maintaining one ID number ensures an accurate history of the bowler's achievements, memberships, tournaments, etc. with USBC, state and local associations. **The bowler's ID number does not change from year to year.**

Please inform your bowlers that by checking the appropriate box on the membership card they do not have to receive non USBC mail.

2. 2023 Legislative Update

- USBC approved string pin bowling center lanes for certification as of August 1, 2023.
- Please make sure that two-handed bowlers are aware that they must use their bowling balls the correct way. If they are using a ball with extra holes (including a thumb hole) it is not acceptable in leagues or tournaments.

3. Awards

USBC only provides adult or youth awards for high achievement 300-game and 800-series recognition. The Seacoast NH Local Association will continue to issue some game and series awards. Please see the enclosed **NEW** award application or select it from the Seacoast NH website (www.seacoastnhusbc.com). You can also submit the awards form from the BLS software. Bowler must meet the average criteria for the achievement to earn the award. Applications and submittals must be sent to the Association Manager within **30 days** of the achievement date so the league bowler can be recognized in a timely manner. This will also ensure award availability. The Association Manager must also be notified within **48 hours** of any high achievement score and the application should be submitted within 30 days.

4. Parental Consent

A "Parental Consent" form must be completed by the parent or legal guardian of any unmarried high school student under the age of 18 who wishes to join an adult league. Also, USBC Athlete Safety Program requires adult members 18 years of age or older who bowl in a league with USBC Youth members 17 years of age or younger to complete the U. S. Center for SafeSport training on a yearly basis.

5. Seacoast NH website (www.seacoastnhusbc.com). The website provides information about the Association including available awards, yearbooks, final averages, tournament information, board members, etc. We also have a Facebook page **Seacoast NH USBC**.

This checklist is a quick review of the league's operational duties. The details of each officer's duties can be found in the Playing Rules book and in the following pages of this manual.

The basics of getting your league up and rolling...

- ☐ Have a meeting to adopt rules before the first session of bowling.
- ☐ Establish the league account with two signatures for withdrawals and statements sent to the president.
- ☐ Post a league schedule in center or distribute to each team captain.
- ☐ Have all bowlers complete membership applications and pay fees in accordance with USBC Rule 101.
- ☐ Send completed USBC league application and fees to your local association(s) within 30 days from the start of the schedule.
- ☐ Adopt a prize/awards list within five (5) weeks of the start of the schedule.
- ☐ If your league includes bowlers under age 20, discuss Youth Membership Eligibility Rule 400 with league members.
- ☐ If your league includes unmarried grade or high school students under the age of 18, a parental consent form must be completed and submitted.

The basics of keeping your league rolling...

- ☐ Post or distribute current standing sheet. You can also upload the standing sheet on BOWL.com.
- ☐ Distribute recap sheets and pay envelopes.
- ☐ Collect all fees and pay bowling center fees.
- ☐ Deposit money into the league account within seven days.
- ☐ Collect recap sheets and calculate the league records.
- ☐ Check if any awards were earned and process within 20 days of the score bowled. A complete list of USBC awards can be found on BOWL.com.
- ☐ Have new bowlers complete membership applications and pay fees in accordance with USBC Rule 101.
- ☐ President or Youth league supervisor must verify league account balance monthly.



Consent Form (for Youth bowling in Adult competition)

This form must be given to EACH competition official **prior to** bowling, substituting or pacing in any USBC Adult competition. (The form is not necessary for youth or adult/youth competitions.)

USBC Rule 13:

Individuals under the age of 18 must have written consent of a parent or legal guardian before participating in any USBC Adult league or tournament.

When individuals under the age of 18 participate in any such competitions, the consent form must be on file with each league secretary or tournament manager prior to participation, and:

- A. Must be signed by youth and parent/legal guardian
- B. Must be given to league secretary or tournament manager
- C. Is good only for the duration of that specific event

Failure to file the Consent Form will cause the player to be ineligible and subject games bowled to forfeiture or disqualification. (See USBC Rules 119 for leagues and 329 for tournaments.)

By signing this form, I certify:

- 1. I have read and understand Rule 400 as it applies to participating in this competition and the effect it may have on USBC Youth membership.
- 2. I understand to ensure compliance with grade, high school and collegiate competition I should check with the compliance officer and/or athletic/activities association.
- 3. I understand accepting prizes may be in violation of Rule 400, which is subject to disciplinary action including the potential loss of USBC Youth membership.
- 4. I understand by bowling in, or accepting any prizes, eligibility to compete in grade/high school and collegiate athletics may be jeopardized.
- 5. I agree, as a parent or guardian, that I have access to and have read the U.S. Center for SafeSport policies, adopted by USBC, which are available at https://www.bowl.com/Registered_Volunteer_Program/RVP_Home/RVP_Policies/.
- 6. I agree, as a parent or guardian, that I (or an authorized adult I have designated) will be in the presence of my child at all time during any adult league or tournament.

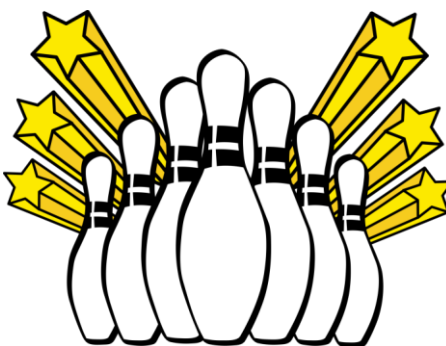

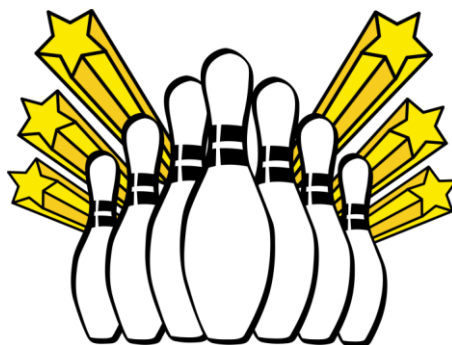
